## 3. General contractor - infrastructure work (Strathearn Avenue North)

WHEREAS the Town of Montreal West issued a public call for tenders for the purpose of awarding a contract for major infrastructure work on Strathearn Avenue North;

WHEREAS fourteen tender documents were ordered;

WHEREAS nine tenders were received;

WHEREAS the engineering firm Avizo analyzed the tenders, evaluated their conformity and recommended that the contract be awarded to the lowest conforming bidder;

#### THEREFORE:

It was moved by Councillor Maria Torres, seconded by Councillor Elizabeth Ulin and resolved:

- 1) That the contract for road, aqueduct and sewer work on Strathearn Avenue North be awarded to the lowest conforming bidder, Duroking Construction Inc., for a price of \$679,518.53 (excluding taxes).
- 2) That this expenditure be charged to Loan By-Law No. 2016-003.

3) That the Mayor and the Town Clerk be authorized to sign any contract and other documents required to implement this resolution, as the case may be.

# 4. Supervision contract – infrastructure work (Strathearn Avenue North)

WHEREAS the Town of Montreal West issued a call for tender by invitation for the purpose of hiring an engineering firm within the scope of its 2016 infrastructure renewal program;

WHEREAS three firms were invited and two of them submitted a service offer which was evaluated by a committee on the qualitative level before its members could take the element of price into consideration;

WHEREAS one firm could also be evaluated on this element as a result of the process, which was conducted as required by the applicable legislation;

#### THEREFORE:

It was moved by Councillor Colleen Feeney, seconded by Councillor Elizabeth Ulin and resolved:

- 1) That the contract for professional services of supervision within the scope of infrastructure work on Strathearn Avenue North be awarded to Avizo Experts-Conseils Inc. for a price of \$27,550.00 (excluding taxes).
- 2) That this expenditure be charged to Loan By-Law No. 2016-003.
- 3) That the Mayor and the Town Clerk be authorized to sign any contract and other documents required to implement this resolution, as the case may be.
