3) That the Public Security Lieutenant, Mr. Demetrios Georgiou, be authorized to represent the Town and to sign on its behalf the application form as well as any other document for the purposes of this resolution.

4. <u>Support program for sports and recreation facilities - Phase IV (Community and Recreation Center)</u>

1) That the Town of Montreal West apply to the Ministry of Education and Higher Learning for a grant under the Support program for sports and recreation facilities (Phase IV) to fund the construction of a new Community and Recreation Center.

2) That the Town undertake to pay its share of the eligible costs for the carrying out of this project, as well as its operating costs once completed.

3) That the Director General of the Town of Montreal West, Me Raffaelle Di Stasio, be authorized to represent the Town and to sign on its behalf the subsidy application form as well as any other document for the purposes of this resolution.
