MINUTES REGULAR COUNCIL MEETING

DECEMBER 18, 2017 8:00 p.m.

Minutes of the Regular Meeting of the Council of Montreal West held on December 18, 2017 at the Town Hall located at 50 Westminster Avenue South.

Mayor Beny Masella acted as chairperson of the meeting. Mr. Claude Gilbert, Town Clerk, acted as secretary of the meeting.

Twenty-two (22) residents and visitors were in attendance.

1. Opening of the Meeting

It was moved by Councillor Elizabeth Ulin, seconded by Councillor Maria Torres and resolved:

That the Meeting be declared open.

2. Acknowledgement of Visitors

5. Correspondence

There was nothing under this item.

6. Report of the Mayor

Mayor Masella announced that he was elected chairman of the Association of Suburban Municipalities (ASM). The ASM represents the interests of related municipalities within the Agglomeration and will seek to work with Montreal Mayor Valérie Plante. As chairman, he will be called to sit on the board of the Communauté métropolitaine de Montréal (CMM) and of the Union des Municipalités du Québec. Concerning grant applications, he noted that it was repeated before and after municipal elections that the Town would apply to other subsidy programs if any were available, which has happened. He also mentioned that residents on Percival were consulted regarding infrastructure work that will be done next year on that street. Finally, he said that the next Coffee with the Mayor will be January 25.

7. First Public Question Period

The Mayor announced the beginning of the First Public Question Period at 8:40 p.m.

Residents were invited to ask the Mayor and Councillors questions concerning matters of general interest.

Laura Cousineau thanked all Council members for their work, and also thanked those people who voted for her during the election. She said that on their behalf, she would advocate environmental issues. For instance, it would be a good thing to find ways to reduce garbage pickup, like a by-law mandating to put organic waste in paper bags. The Mayor said it was fair to discuss such issues. Councillor Ulin agreed. The Town is already encouraging good practices like that, but up until now has always used carrots instead of sticks.

Barbara Malcomson-Baily said that residents should be properly informed when there are reports of criminal activity in their neighborhood, and some kind of monitoring in the sense of crime watch would be good. Mayor Masella said that notices were distributed to residents in the past, when there were a series of car crashes. Councillor Mazzone added that the Traffic and Safety Committee (TSC) will discuss ways of increasing neighborhood awareness.

Norbert Bedoucha noted that the presence of curb extensions on Westminster should be made more visible in the winter. Mayor Masella said the Town will continue to improve their visibility, but they are there to stay. On another subject, the resident asked how the Town is trying to involve the Canadien National (CN) in discussions regarding problems with Turcot yards. The Mayor remarked that Transports Québec, not the Town, is running the neighborhood committee for the Turcot project. He added that the Town will continue to advocate the residents' views in those meetings and in between. Councillor Mazzone noted that the CN will be at the next neighborhood committee.

Stan Carny asked what it cost in terms of material, equipment and manpower for the tree planting project at Edinburgh School. Councillor Torres explained that this initiative was not just for that school and although it entailed costs, they were not broken down for each place. The resident also had a question about the street lights. Councillor Torres said the decision making process in this file must consider environmental aspects, financial ones and public safety. The Mayor added that the Town will ask someone to validate the appropriate level of lighting in certain areas. On another point, the resident said the Council should restructure the Planning Advisory Committee. Mayor Masella reminded him that it is a provincial law which mandates municipalities to have such a committee in order to deal with certain matters. On the other hand, Council has made a number of bylaw changes to reduce the committee's work load.

lan Robinson expressed concerns about a traffic issue on Ballantyne North. Councillor Mazzone asked him to send an email on this problem.

Stan Carny had a remark concerning the infrastructure project on Percival. The Mayor said that there was a consultation and the residents had the chance to express their views.

The First Question Period ended at 9:10 p.m.

a) Assessment criteria and weighting grid - tender document (Town website)

That the assessment criteria and weighting grid found in sections 4 and 5 of the tender document mentioned in the preamble of this resolution be approved.

b) City of Côte Saint-Luc - by-law regulating the traffic of trucks and tool vehicles

WHEREAS the City of Côte Saint-Luc has adopted a by-law regulating the traffic of trucks and tool vehicles in its territory;

WHEREAS this by-law requires the approval of the Quebec Ministry of Transportation;

WHEREAS the City, in order to obtain this approval, has notified the neighboring municipalities and boroughs of the content of this by-law;

THEREFORE:

It was moved by Councillor Dino Mazzone, seconded by Councillor Maria Torres and resolved:

That the Town of Montreal West inform the City of Côte Saint-Luc that it has no objection to its By-Law No. 2493.

"Council allocates an amount of \$89,131 from the general fund in order to pay the remaining balance for the cost of the work authorized in article 1 of this by-law."

d) Credit allocation - general fund (By-Law No. 2017-002)

17. Second Public Question Period

The Mayor announced the beginning of the Second Public Question Period at 9:50 p.m.

Residents were invited to ask the Mayor and Councillors questions concerning the matters on the agenda of this meeting.

Abby Shyavitz asked what the goal is with the call for tenders concerning the Town's website. The Mayor said the goal is to completely redesign the website while improving its maintainability. The resident also asked what the register of gifts and the statements of pecuniary interests are about. The Mayor explained that it is a requirement for elected officials to declare their properties in Montreal West and in the CMM, as well as their jobs, loans and interests in businesses. As for the register of gifts, no Council member received any so none was declared.

Stan Carny asked a question about speed bumps. Councillor Mazzone said that an analysis has been done of the different types and recommendations were made. As for implementing the changes, it will be done by the Public Works Department.

Cynthia Nichols complained about traffic poles around the corner of Ballantyne and Avon. They slow down traffic too much. The Mayor said their installation was recommended by engineers to increase security. The resident noted that there are stop signs, and the Mayor answered that this was not enough. Councillor Mazzone added that the congestion should be alleviated a bit with the amendment that was adopted tonight to the traffic by-law. The resident, on another point, noted that the art exhibition in the Assembly Hall has stopped for a while now. Councillor Ulin explained that it was removed when Art Etc. was taking place, but will come back.
