• Allow that the rear setback of the main building be 4.38 metres from the property line, while the minimum setback is 6.10 metres in Zone RA-5, the consequence being to reduce this requirement by 1.72 metres.

That the plans and requests submitted to the March 7, 2018 meeting of the Planning Advisory Committee be approved, in accordance with By-Laws 2010-002 and G-18-0005, for the following minor exemptions from sections 3.2.2 of the Zoning By-Law, regarding the immovable located at 11 Brynmor in order to:

- Allow that the rear setback of the garage be 3.19 metres from the property line, while the minimum setback is 6.10 metres in Zone RA-10, the consequence being to reduce this requirement by 2.91 metres;
- Allow the building of an extension over the garage, so that the rear wall of that extension would be aligned on the wall of the said garage.
