There was nothing under this item.

#### 6. Report of the Mayor

Mayor Masella thanked all the volunteers and Town employees who helped with the Christmas Dinner for seniors, and the Breakfast with Santa for families. He noted that the 2020 budget was adopted earlier tonight at a special meeting. In general terms, the tax bill for the average Montreal West home will rise 1.95%. On another point, the Mayor said that the provincial government launched a new program for funding of recreational facilities, and Montreal West has already filed its intent to apply for this grant. He also mentioned that he was re-elected president of the Association of Suburban Municipalities. This position is not an easy one at a time when the relations of demerged municipalities with the City of Montreal have become increasingly difficult. The Mayor thanked the organizations, volunteers and employees who helped make a great success with the stop in Montreal West of the CP Holiday Train. One of those organizations is The Depot, formerly the NDG Food Depot, which the Mayor visited with his wife and which he praised for its work. Finally, he said that the next Coffee with the Mayor will be January 23, and offered his Happy Holiday wishes.

#### 7. First Public Question Period

The Mayor announced the beginning of the First Public Question Period at 8:21 p.m.

Residents were invited to ask the Mayor and Councillors questions concerning matters of general interest.

Bob Barnes discussed the issue of lead water pipes. He wondered what proportion of them are safe. The Mayor said the Town knows 70% are. The resident asked if that means 30% are not, but the Mayor answered it only means we do not know for them. Also, this is only about public pipes; the Town does not know the state of plumbing on the private side. The resident noted that Côte Saint-Luc was criticized for not sharing reports. The Mayor said the reports for Montreal West are up-to-date, the last one dating back to January 2019. The testing is done at selected addresses by the City of Montreal, upon suggestions from Montreal West. The resident asked if these reports and the Mayor said he assumed they are but would follow up.

Cynthia Nichols deplored traffic conditions on Westminster and said the Christmas decorations are not necessarily put in the best places.

Louise Chenevert said there has been waste dumping in the back of the apartment building located at 30 Sheraton. She also said that trees were damaged by a snow removal company around there after a snow fall. Having been invited to comment by the Mayor, the Director General, Raffaelle Di Stasio, answered that she was not aware of this file and would have to come back to the resident.

That Loan By-Law No. 2019-001 concerning infrastructure work on Crestwood and Wolseley Avenues be amended by the addition of the following paragraph to its article 5, in accordance with section 564 of the Cities and Towns Act:

"Council allocates an amount of \$380,000 from the general fund in order to make a partial payment for the cost of the work authorized in article 1 of this by-law."

# e) <u>Subsidy application – Financial support program for recreation and sport infrastructure</u>

- 1) That the Town of Montreal West apply to the Ministry of Education and Higher Learning for a grant under the Financial support program for recreation and sport infrastructure to fund the construction of a new Community and Recreation Center.
- 2) That the Town undertake to pay its share of the eligible costs for the carrying out of this project, as well as its operating costs once completed, to assume any budget overrun related to this project, and to refrain from awarding any contract with respect to direct costs until the grant is announced by a letter from the Minister.
- 3) That the Director General of the Town of Montreal West, Me Raffaelle Di Stasio, be authorized to represent the Town and to sign on its behalf the subsidy application form as well as any other document for the purposes of this resolution.

#### b) Minor exemption request - 75 Courtney

That the plans and request submitted to the November 6, 2019 meeting of the Planning Advisory Committee be approved, in accordance with By-Laws 2010-002 and G-18-0005, for the following minor exemption from the schedule of uses and standards in effect under section 3.2.2 of the Zoning By-Law, regarding the immovable located at 75 Courtney in zone RA-10 to:

• Normalize an encroachment of the main building, which is located at 3.02 metres from the property line, while the minimum front setback is of 4.57 metres, the consequence being to reduce this requirement by 1.55 metres.

#### a) Awarding of contract - purchase of articulated sidewalk tractor

- 1) To award the purchase contract of a Wacker Neuson WL 32 articulated sidewalk tractor (year 2020) to J. René Lafond Inc., being the lowest conforming bidder, for a total price of \$81,665.28 (excluding taxes).
- 2) That this expense be charged to budget code 02-920-30-725.
- 3) That the Director of Public Works be authorized to sign any documents required to implement this resolution, including the delivery and registration of the purchased equipment, as the case may be.

#### 17. <u>Second Public Question Period</u>

The Mayor announced the beginning of the Second Public Question Period at 9:00 p.m.

Residents were invited to ask the Mayor and Councillors questions concerning the matters on the agenda of this meeting.

Cynthia Nichols asked where the money would come from to build a new community and recreation center. The Mayor explained that there is no grant at this time, the Town only made an application under the new program, which may be funded in part by the Federal Government but in any case is managed by the Quebec Government.

Bob Barnes said he was enthusiastic about the new arena project and wondered if there was something people like him could do to help. The Mayor told him that Town has yet to complete its home work to make sure the application file is conform.

Louise Chenevert asked a question about the tax rate for duplexes. Councillor Feeney answered it is the same basic rate as for single residential buildings. The new real estate valuation roll showed a lesser increase of value for duplexes than in previous years.
