# 5. Correspondence

There was nothing under this item.

# 6. Report of the Mayor

The Mayor said that after a few weeks of not hearing of idling trains behind Ronald Drive, a train was caught idling on October 19. He notified his contacts and was later informed that this was not an emergency situation and that the crew was being investigated and reminded of the importance of enforcing the directives. On another point, he mentioned that, last fall, the Town was victim of a ransomware attack, last fall. As soon as the threat was discovered, a team of cyber security experts was hired to put all necessary measures in place to remove all traces of the virus and secure the environment. The network was quickly restored, and an investigation was opened to better understand the origin and the impact of the virus attack. The situation is now under control and there is no evidence that any personal information has been accessed, used or communicated. However, the Town did not want to take any risks and decided to offer free credit monitoring surveillance with a firm, TransUnion, to those whose information may have been compromised. On another point, the Minister of Municipal Affairs announced that the provincial government was earmarking \$800M for the municipalities across the province to help them offset the extra expenses and reduced revenues caused by this pandemic. Each is free to use the funds as needed, including to offset any increases from the Agglomeration. Montreal West will receive almost \$503,000 - some in 2020 and some in 2021. Finally, the Mayor noted that the coming Saturday is Halloween. Trick or treating is allowed but children can only go out with kids in their own households. He invited the residents to do their part to ensure the overall safety of the community.

# 7. First Public Question Period

The Mayor announced the beginning of the First Public Question Period at 8:10 p.m.

Given the circumstances, residents had been invited to submit in advance their questions concerning matters of general interest to the Mayor and Councillors.

#### 1. Xavier MacLaren

Asked for a dedicated bicycle lane on Westminster Street.

# 2. Kristopher Mariani

Asked when the construction to redo Percival Avenue between Curzon and Nelson will take place.

# 3. Adelle Blackett

Asked if the Town might consider discussions with Meadowbrook golf course to secure regular access for residents to the grounds for cross-country skiing and other outdoor activities during the winter months.

#### 4. Donna McLaughlin

In view of the amount of vacancies on Westminster, asked what the Town plans to do about enticing new business and keeping existing ones.

# 5. Giuseppe Abbatiello

Complained that household garbage is dumped at the Toe Blake Park recycling bin adjacent to the golf course on Fridays, to be picked it up on Mondays.

# 6. Gerry Ahronheim

Signalled the presence of some sort of mildew on numerous lawns this past summer, with patches of lawn where grass seemed to die, then were slowly replaced by small weed.

#### 7. Patrice Archambault

Asked why the dog park remains open while no one wears a mask and physical distances between humans are not kept.

# 8. Ellen Moore

Noted that used kleenexes are now allowed with compost materials by some municipalities. Asked why glass is not collected separately for recycling, to prevent breakage and permit genuine recycling, and also what happens to the toilets left on the curbsides.

#### 9. Mike Elie

Concerning the radar/traffic signage on Ronald, noted that it often does not work due to it being in a shaded location. Asked for tree trimming or relocating of the solar panel. Also asked for two yellow signs "ralentissez: attention à nos enfants" similar to the ones on other streets. Finally, asked that public works employees occasionally rake the wood chips at Ronald Park to better protect kids from the metal sewer grate near the bench.

#### 10. Marsha Milstock

Asked that senior citizens and handicapped home owners be allowed to put up temporary driveway structures during the winter months.

#### 11. Ian Robinson

Wondered if the Mayor could provide an update on progress if any on the proposed new recreation center.

#### 12. Peter McLean

Asked the Town to do something in regards to bicycles on sidewalks. Also asked to put a waste container at the corner of Nelson and Westminster by the bus stop.

#### 13. Catherine Dixon

Heard at the EXO presentation that there would be a request to close the sidewalk, South of the tracks on the East side of Westminster, and that everyone walk on the West side.

#### 14. Armand Aalamian

Asked the Town to monitor and discourage gatherings of children and adults in public parks and on the streets. Also asked that the Town do something about dog owners who let their animals run unleashed outside of the exercise area on Hodgson Field.

# 15. Pierre Dessaulles

Asked where to call if he witnesses a large gathering in someone's house, like the one he saw last week-end.

# 16. André Langlois

Asked for an update on the road conditions in Montreal West and how the Town plans on better correcting the situation, since the patch work is non-lasting.

#### 17. Mike Peytchev

Asked the Town to help residents persuade Transports Québec to build a protective wall next to Ronald Drive or go to the federal level to convey this request.

#### 18. Bill Olshefsky

Asked for better communication and instructions the next time hydrants are flushed as per maintenance procedures, so that people can fill posts the night before in order to have drinking water the next morning, when there is brown running water.

- 2) That the Mayor and the Director General be jointly authorized to sign this deed of sale on behalf of the Town.

# c) <u>Mandate to the Union des Municipalités du Québec (UMQ) – group purchasing of reputation and privacy insurance coverage and of penal liability insurance coverage for health and safety at work</u>

WHEREAS the Town of Montreal West, in keeping with section 29.9.1 of the Cities and Towns Act (CQLR, c. C-19), is interested in joining a group set up by the Union des municipalités du Québec (UMQ), on its behalf and on behalf of other municipalities, in order to purchase insurance products for the protection of reputation and privacy of elected and administrative officials and of penal liability risks for health and safety at work, during a term extending from 2020 to 2025;

#### THEREFORE:

It was moved by Councillor Maria Torres, seconded by Councillor Elizabeth Ulin and resolved:

- 1) That the Town agree to take part in the purchasing group set up by the UMQ, for the purpose of obtaining insurance coverage for the protection of reputation and privacy of elected and administrative officials and of penal liability risks for health and safety at work, the term of this agreement beginning December 31, 2020 and ending December 31, 2025.
- 2) That the Mayor and the Town Clerk be authorized to sign the agreement entitled "Entente de regroupement de municipalités au sein de l'Union des municipalités du Québec relativement à l'achat en commun d'assurances protection de la réputation et de la vie privée des élus et hauts fonctionnaires et d'assurances responsabilité pénale en matière de santé et sécurité (C-21)", a copy of which is included in appendix to this resolution and shall be deemed an integral part thereof.
