

**2022 PRE-BUDGET CONSULTATION**  
**Virtual public consultation**

The Commission sur les finances et l'administration (the committee) invites interested parties to take part in the 2022 pre-budget consultation which will be held by videoconference, in accordance with the guidelines in effect during the pandemic.

The consultation will be held in three parts. In the first part, participants will have an opportunity to review the consultation file, ask questions and get answers on the subject of the consultation. During the second part, participants can express their views. The third part will consist of a session during which the committee will adopt its recommendations.
