#### 3. <u>Municipal Asset Management Program of the Federation of Canadian</u> <u>municipalities (FCM) – grant application</u>

WHEREAS the Municipal Asset Management Program is operated and delivered by the FCM and funded by the Government of Canada;

WHEREAS this program is implemented in partnership with municipal and provincial organizations and key stakeholders that support the improvement of municipal practices in relation to asset management;

WHEREAS asset management requires a comprehensive and integrated approach in respect of community infrastructure, and as such it requires to evaluate all relevant factors, like purchase, replacement and ongoing maintenance costs, plus social implications,

WHEREAS the purpose of this program is to help municipalities to provide their residents with the services they need at reasonable cost;

WHEREAS the key of efficient asset management lies mostly on access to appropriate, accurate and recent data;

WHEREAS the benefits for the town that are derived from the health check of municipal buildings and the definition of a framework for the immovable asset management were made possible by the Municipal Asset Management Program of the FCM (reference: Resolution # 20181022-003);

WHEREAS the FCM is striving to meet the highest governance standards for municipalities in terms of asset management in order to help them realize structuring projects that can support the achievement of this goal;

#### THEREFORE:

It was moved by Mayor Beny Masella, seconded by Councillor Maria Torres and resolved:

THAT the Town of Montreal West file a grant application under the Municipal Asset Management Program of the FCM to upgrade its information as well as its inventory and financial data in order to perform an assessment of its vehicle fleet.

THAT the Town undertake to carry out the following tasks within the scope of the project introduced under the said program to improve its own asset management program:

- draft a management plan of its vehicle fleet;
- collect related data to produce a report;
- train its employees with respect to managing vehicle assets.

THAT the Town commit itself to spend an amount not exceeding \$46,000.00, it being understood that the grant from the FCM shall reimburse 80% of the eligible project costs.

THAT the Director General be authorized to sign any and all necessary documents to implement this resolution.
