6. Adoption of By-Law No. 2021-004 - By-Law amending Contract Management By-Law No. 2019-004

7. The Easton - Agreement on municipal works

WHEREAS the promoter of The Easton project intends to erect a mixed-use building on lot 1 292 196 (current address being 45 Westminster Avenue South);

WHEREAS there are underground infrastructure in the middle of that lot (water and sewer pipes) that will have to be relocated as a result of this building project;

WHEREAS the Town and the owner deem it in their common interest to reach an agreement where the responsibilities of each stakeholder will be clearly set out;

WHEREAS the Town is allowed to conclude such agreements, in accordance with By-Law No. 2019-005 respecting municipal works agreements;

THEREFORE:

It was moved by Councillor Elizabeth Ulin, seconded by Councillor Maria Torres and resolved:

1) That the proposed agreement on municipal works that has been negotiated with Le Développement Easton S.E.C. / The Easton Development L.P. be approved.

2) That the Director General, Me Raffaelle Di Stasio, be authorized to sign the said agreement on behalf of the Town of Montreal West.

8. Awarding of contract – sidewalk repairs

- 3) To authorize the Mayor and the Town Clerk to sign any documents required to implement this resolution, as the case may be.
