3. Notice of Motion and Deposit of Draft By-Law for a By-Law Concerning Taxes of the Town of Montreal West for the Fiscal Year 2023

Mayor Masella gave notice of motion that it is intended at a subsequent Meeting of Council to submit for adoption a "By-Law Concerning Taxes of the Town of Montreal West for the Fiscal Year 2023".

The said By-Law, in draft version, was tabled with Council and made available to the public.

4. Communauto Flex requests – extra parking places and parking rules exemptions

WHEREAS Communauto offers car renting services tailored to diversify the ways residents travel in the city in a sustainable and efficient fashion;

WHEREAS there are two places reserved for Communauto vehicles in Montreal West at the municipal parking area on Westminster;

WHEREAS Communauto has made a proposal to further facilitate the use of its vehicles by allowing users to park them on streets, this being called Communauto Flex;

WHEREAS Communato has also asked that two other spaces for parking two vehicles in each be authorized in Montreal West, one at the Town Hall and the other at the corner of Northview and Brock;

THEREFORE:

It was moved by Councillor Elizabeth Ulin, seconded by Councillor Maria Torres and resolved:

- 1) That the request of Communauto for two more parking places in Montreal West be refused.
- 2) That Communauto Flex vehicles be allowed to park on Montreal West streets on a trial basis until December 15, 2023, in compliance with the following conditions:
 - A. Such vehicles will be exempt from traffic by-law requirements pertaining to overnight parking prohibition and four-hour parking limit.
 - B. Nonetheless, these vehicles shall remain subject to all other traffic by-law requirements including, but not limited to, 60-minute parking limit on Westminster as well as snow removal and street cleaning restrictions.

6. <u>Hiring of an Environment Coordinator – maternity leave replacement</u>

- 2) That the Director General by interim be authorized to sign this contract on behalf of the Town.
