BY-LAW No. 2023-003 AMENDING BY-LAW No. 2023-001 ORDERING THE CONSTRUCTION OF A NEW SPORTS AND RECREATION CENTER TO INCREASE THE EXPENDITURE AND AUTHORIZED LOAN BY AN ADDITIONAL AMOUNT OF \$6,686,024

REFERENDUM POLL OF JUNE 18, 2023

PUBLIC NOTICE is hereby given by the undersigned Town Clerk of the Town of Montreal West:

- to sole owners of an immovable and sole occupants of a business establishment, who do not already have the right to be entered on the referendum list as a domiciled person, that they may be entered on the referendum list for the current polling, provided that the following conditions are met:
 - 1. must be a physical person of full age on April 27, 2023;
 - 2. must be a Canadian citizen and, at this date, must not have lost the right to vote under a tutorship, and not have been convicted, in the past five years, of an offence that is a corrupt electoral practice;
 - 3. must be the sole owner of an immovable or the sole occupant of a business establishment located in the territory of the municipality, since at least April 27, **2022**;
 - 4. must have delivered to the municipality, at the address noted below, an application for entry on the referendum list at the latest on May 19, 2023;
- to undivided co-owners of an immovable and co-occupants of a business establishment, who do not already have the right to be entered on the referendum list as a domiciled person, or as the sole owner of an immovable or as the sole occupant of a business establishment, that they may be entered on the referendum list for the current polling, provided that the following conditions are met:
 - 1. must be a physical person of full age on April 27, 2023;
 - 2. must be a Canadian citizen and, at this date, must not have lost the right to vote under a tutorship, and not have been convicted, in the past five years, of an offence that is a corrupt electoral practice;
 - 3. must be the undivided co-owner of an immovable or co-occupant of a business establishment located in the territory of the municipality, since at least April 27, **2022**;
 - 4. must have been designated in a power of attorney signed by the majority of co-owners or co-occupants who are qualified voters on April 27, 2023;
 - 5. must have delivered to the municipality, at the address noted below, an application for entry on the referendum list at the latest on May 19, 2023.
- to legal persons which are qualified to vote since at least April 27, 2022, that they may be entered on the referendum list for the current polling, provided that the following conditions are met:
 - 1. must have designated, by resolution, one of its members, directors or employees who is natural person of legal age and a Canadian citizen and who must not have lost the right to vote under a tutorship, and not have been convicted, in the past five years, of an offence that is a corrupt electoral practice;
 - 2. must have delivered to the municipality, at the address noted below, an application for entry on the referendum list at the latest on May 19, 2023.

PLEASE NOTE that the application for entry, power of attorney or resolution delivered after May 19, 2023, but received no later than May 30, 2023 (last day to file a request with the Board of Revisors) will be considered as an application to amend the referendum list.

A template of application for entry, of a power of attorney or of a resolution may be obtained at the office of the undersigned. Such applications, powers of attorney and resolutions shall become effective upon receipt and shall remain in effect until they are withdrawn or replaced.
