Minutes of the Regular Meeting of the Council of Montreal West held on April 24, 2023 at the Town Hall located at 50 Westminster Avenue South.

Thirty (30) residents and visitors were in attendance.

1. Opening of the Meeting

It was moved by Councillor Lauren Small-Pennefather, seconded by Councillor Colleen Feeney and resolved:

That the Meeting be declared open.

2. Acknowledgement of Visitors

There was nothing under this item.

3. Adoption of the Agenda

It was moved by Councillor Colleen Feeney, seconded by Councillor Elizabeth Ulin and resolved:

5. <u>Correspondence</u>

There was nothing under this item.

6. Report of the Mayor

Mayor Masella reported that the Town opened the bids for the Sports and Recreation Centre and the bids came in above last estimates. Because of that, it is necessary to adopt a modified loan by □law. Exactly as was the case with the loan by-law adopted in February, this is subject to a register. The register will be opened for signature on May 5. If there are 391 signatures on the register, it forces a referendum. Though the referendum will officially be about the loan by-law, it would be about voting on the project as a whole. If there are less than 391 signatures, there will be a vote anyways. In either case, the vote will be on June 18. The whole Town will vote upon it and Council will respect the majority of votes cast. To be perfectly clear, there is no Plan B as some people may have implied. If the project is not approved by the residents, there is no other plan ready to go. The Town has received written confirmation that removing the rink from the project is a major modification and would need re-approval. Such a prospect is not guaranteed. It would mean to restart designing a different project and get in line looking for grants. The last provincial budget spoke of \$300 million for recreational facilities for the whole province, spread over 10 years. That translates to \$30 million per year. Parallel can be drawn with the situation in 1964 when the Town was deciding whether or not to build the Legion Rink. The same pros and cons were discussed then and the concerns were eerily similar. The Town did not implode and go bankrupt. And that facility survived 59 years so far and has served a few generations of residents. The Mayor asked for the same courage those residents had in 1964 to build a facility that will serve for the next 60 years.

7. <u>Councillors' Reports</u>

a) Seat Number 4

Councillor Maria Torres reported on matters pertaining to Urban Planning (1) and Environment (2).

b) Seat Number 1

Councillor Lauren Small-Pennefather reported on matters pertaining to Public Security and Urban Planning (2).

c) Seat Number 2

Councillor Elizabeth Ulin reported on matters pertaining to Public Works, Communications and Environment (1).

d) Seat Number 3

Councillor Colleen Feeney reported on matters pertaining to Finance, Recreation and topics related to the status of Age Friendly Municipality.

8. First Public Question Period

The Mayor announced the beginning of the First Public Question Period at 8:30 p.m.

Residents in attendance were invited to ask the Mayor and Councillors questions concerning matters of general interest. Questions submitted in advance were also taken.

1. Harold Knowles

Asked if the arena project could still go forward in the event that the amendment to the loan by-law was not enacted. Also asked if there would a second vote in that case.

2. Joanna Duy

Wondered if Montreal west could have partners in the arena project, like the Town of Hampstead. Also asked for precisions about who could sign the register and vote in a referendum.

3. Kurt Johnson

Said that the recreation center was on the platform of many elections. Wanted to know if there will be more than one occasion to vote.

4. Paul Kenton

Asked a question concerning the cost of the architect hired for the arena project in the planned budget according to the loan by-law. Also wondered about cost overruns.

5. André Lavoie

Asked if the Town could scale down the arena project without losing the grant. Also wanted to know what happens next if the project does not go forward, in particular with the demolition work.

6. Sébastien Faria

Said that according to his insurance company, his house has a 95% risk of getting sewer backups because of the state of the underground municipal infrastructure. Also, said that the fiscal impact of a new arena would be reflected on rental costs for tenants.

7. Robert Soden

Asked how is called the event to be held on May 5 concerning the loan by-law. Complained that people are not informed enough about it.

8. Daniel Boulerice

Asked if the Town may consider keeping the old arena in the event that the amendment to the loan by-law is rejected and the project for a new one does not go forward.

9. Andrzej Manitius

Asked a question about the interest rate estimated for the loan by-law project costs.

10. Michael Schindler

Asked if the appendices to the amending loan by-law are accessible.

11. Cynthia Nichols

Complained about water network problems, among others.

12. Ivona Manitius

Asked if the Town printed and distributed door to door a notice about the loan by-law register on May 5.

13. Pascal Bricault

Asked if there are any updates on government subsidies to finalize the road work on Brock North.

14. Sylvia Gervais

Since gas leaf blowers will be banned in the Town soon, asked when will gas lawn mowers be banned.

15. Neil Price

Asked if residents will be allowed to sign the by-law vote register even if they are unable to do so on Friday, May 5.

16. Frank Opolko

Wanted to know who on Council is in favor of building a new arena and why. Also asked that all costs for future maintenance and security will be covered by users of this facility, regardless of outside subsidies for the building.

17. Stan Carny

Suggested that the Town install banners/posters on Westminster, at Town Hall, in places of worship, so that the maximum amount of people be informed of the loan by-law register. Also wondered if the construction project costs include any for demolition.

18. Daniel Gideon

In regards to the new arena project and its cost being over budget, asked if the tenders were analyzed for the contents, if the architect and other professionals on the team looked at value engineering the project to save money, and if the lowest bidder has been asked if it has cost saving proposals.

19. Judy Kennedy

Asked how does the Town justify a cost per resident of \$423 each year for a new arena, and if any alternatives were considered.

20. Andre Chenier

As the Town will receive from the Federal and Provincial governments a grant of \$12.5 million, asked if the Town will have to obtain a bridge loan until the recreation center is built before receiving the subsidies.

21. Linda Hammerschmid

Noted that Westmount built a \$40 million sports complex ten years ago, but it has three times the fiscal base of Montreal West, not including the commercial tax revenues it can count on. Asked for a smaller project.

22. Jake Barralet

Asked what would be required to put the power lines underground, and what would be the cost and process to initiate it. Also wondered about sinkholes and asked for a list of the extent of the infrastructure degradation relevant to sinkholes.

23. Michael Elie

Asked the Town ticket or force the owner of two vacant lots on Brock South to clean up and properly secure these spaces.

24. Catherine Beaubien

Regarding the June 3 Town wide garage sale, asked if this will be advertised outside of Montreal West.

25. Christine Grandjean

Said that last fall, residents of Crestwood and Sheraton were given a survey to voice their preference on different proposed projects for Sheraton Park. Asked when the results of this survey will be shared.

26. Gerry Ahronheim

Wondered if the possibility of Montreal West residents using some of the facilities in Côte Saint-Luc has been considered, as an alternative for a new recreation center.

27. Howard Barza

Asked when Council will admit that the recreation center is not financially viable, knowing that the original projections for the cost have increased by at least 17 million dollars since 2019, that the estimated increased cost of municipal taxes to be borne annually by residents has increased more than four times (not including any cost over-runs) and that the Town is now obliged to seek further authorization to increase its loan by-law.

28. Tony Ciamberlano

Asked if there are any estimates of the operating costs for the new recreation center compared to current operating costs.

29. Jennifer Melnick

Asked if the revised cost estimate for the arena at \$38 million includes any portion for a second phase of the project (such as a soccer field, basketball, track, and so on) and if yes, what is the amount allocate, and if no, what is the current estimate for that part of the project, and when phase 2 is supposed to happen.

30. Norbert Bedoucha

Considering that the Town has not been and is not financially viable, asked how Council can envisage an expenditure of \$40 million, over and above the \$17.2 million of bank debt it currently has, on a Sports Complex that will add at least \$456/yr/taxpayer for a duration of 40 years.

31. Richard Gianfelice

Asked for a vote on the new sports and recreation center as such, instead of voting on the amendment of the loan by-law instead.

32. Cynthia Koomas

Asked if the register on May 5 is solely open to property owners or if renters are included. Also wondered if it only one person per household who is allowed to sign, or if it inclused all persons residing at a given address.

The First Question Period ended at 9:35 p.m.

9. Contracts and Town Clerk's Office

a) Common legal challenge of certain provisions of the Chapter 14 of the Statutes of Quebec of 2022 (Bill 96)

WHEREAS the Town of Montreal West has been invited to join the City of Côte Saint-Luc as a co-plaintiff, along with other municipalities, to contest some of the new rules and regulations that were introduced by the law quoted in title of the present resolution;

WHEREAS it is understood that the costs of this court challenge will be shared among participating municipalities on a pro-rata basis following the relative size of each municipality's population;

THEREFORE:

It was moved by Councillor Lauren Small-Pennefather, seconded by Councillor Colleen Feeney and resolved:

1) That the Town of Montreal West join with the City of Côte Saint-Luc as a co-plaintiff in contesting articles of Bill 96, including the filing of a stay of proceedings, where appropriate, and in the eventual contestation on the merits, in order to avoid the detrimental and financial effects that Bill 96 will have on bilingual municipalities.

- 2) That the Town agree to share the legal fees and costs with the City and other coplaintiffs, on a pro rata basis following the relative size of the population of each of the coplaintiffs, said fees to be invoiced and paid in a timely fashion.
- 3) That the Town recognise, for the purpose of efficiency and cohesion in this matter, that the City of Côte Saint-Luc will be the representative of all co-plaintiffs in communications and instructions with Grey Casgrain s.e.n.c.
- 4) That Mayor Beny Masella be authorized to sign a mandate with the Law Firm of Grey Casgrain s.e.n.c. to allow them to represent Montreal West in these proceedings.

b) Minor exemption request - 71 Strathearn North

That the plans and request submitted to the March 22, 2023 meeting of the Planning Advisory Committee be approved, in accordance with By-Laws 2020-002 and G-18-0005, for the following minor exemption from the schedule of uses and standards in effect under section 3.2.2, regarding the immovable located at 71 Strathearn North in zone RA-6 to:

Authorize a combined lateral setback of the main building of 3.2 metres instead of
the minimum 4 metres required in that zone, the consequence being to reduce the
requirement by 0.8 metre, conditional upon complying with resolution 20230227-011
that allows an extension in the back yard with a setback of zero (0) metre from the
shared property line with the attached building.

WHEREAS the Director of Public Works will act as representative of the Town of Montreal West in this regard;

THEREFORE:

It was moved by Councillor Elizabeth Ulin, seconded by Councillor Colleen Feeney and resolved:

- 1) That the Council authorize the participation of the Town of Montreal West in a group call for tenders for the purpose of awarding contracts for the supply of road salt in bulk.
- 2) That the Town of Montreal West delegate to the City of Montreal the power to prepare the specifications and other tender documents, to proceed with the calls for tenders, to receive and to analyze the offers, and to report the results to the participating municipalities.
- 3) That the Director of Public Works and the Assistant Director of Public Works be each authorized to sign any necessary documents to implement this resolution.

Scott Mackenzie asked if the Town's has estimates for rebuilding the pool as part of the recreation center project. He also expressed support for that project.

Joanna Duy wondered if such an increase to the loan for the recreation center can be achieved through a simple by-law amendment.

Cyrille Vittecoq asked if all the tenders for the construction contract were conform and what is the difference of price between them.

Robert Deslauriers asked if the Town has a policy on graffiti removal.

Stéphane Garcies asked if the Town has considered whether it will have the financial capacity to undertake other infrastructure work if it has invested too much on the arena.

Katherine Lund asked if the Town has taken into account the effect on inflation on its estimates for the new recreation center.
